- 1.1.2** Following ICAO code letter F ACFT:

 - b) A380 / An-124 for diversions
 - c) A380 for training flights without pax
- 1.1.3** All other ACFT with PPR

- All military ACFT's
- Night airmail service according Annex 16, Chapter 4
- STR as emergency and alternate aerodrome for meteorological, technical or other safety reasons
- On disaster relief missions or when rendering medical assistance
- Flight checks conducted by DFS
- Admission by the approving authority of Stuttgart Airport
