- 2.1** ARR / DEP: MON-FRI (2000-0400), SON, HOL (1800-0600), PROP with MTOW < 2t and power gliders, if they fall below the noise limitation according Annex 16, Chapter 6, 10 by at least 8dB (A)
- 2.2** ARR / DEP: MON-FRI (2000-0400), SON, HOL (1800-0600), PROP with MTOW > 2t, if they fall below the noise limitation according Annex 16, Chapter 6, 10 by at least 4dB (A)
- 2.6** DEP: RWY 28, ARR: RWY 10 (except use of RWY is suspended by meteorological and flight safety reasons) this ruling applies for PROP with tail wind component up to 10kt and JET with MTOW < 150t with tail wind of up to 5kt DEP of ACFT with MTOW > 150t only RWY28
- 2.7** SCHED-, Charter- and Cargo-FLT and other airtraffic
